- The April 18 fire was extinguished yesterday. Approximately 5 acres of private burned. BLM assisted with fire suppression and returned to their home units safely.
- 2. While on the fire during mop up operations, BLM personnel an individual off of one of the Clark County ambulances starting asking the BLM personnel if they worked on the Bundy roundup. When advised that they were not involved with that operation, the paramedic started ranting about Harry Reid teaming up with the Chinese and telling us how out of control the BLM Rangers were. He talked about how one of the BLM Rangers had cited him unfairly and he took it to court and won. He then proceeded to tell us how he is pro-Bundy and BLM had no right taking land or cows from Bundy. This individual stated that he spent all day Saturday on the side of I-15 in his ambulance in case someone got shot during the protest. He stated "I told the metro officer that I would pick up a shot protester before I would pick up a shot BLM Ranger."

Dan's Demobilization Order (Sent via email today at 14:41)

FOR ALL PERSONNEL:

This email and message from the command staff will serve as your official demobilization order. Please adhere to the schedule and check in with your team leaders as designated.

Command thanks you for your efforts during this operation. Your continued professionalism is appreciated at all levels within the Department of Interior. We recognize the difficult events we were confronted with on Saturday April 12, 2014. In the wake of those events, command worked diligently to ensure we had everything needed for a future criminal case against those who were involved in disrupting our mission through the threat of violence. We thank you all for taking the necessary time to prepare written reports, download video evidence, and participate in witness interviews. We also recognize how quickly you were able to adapt and handle new missions and threats to successfully conclude this operation. We provided immediate access to EAP and CISM for those who wanted to talk about the events, and we would encourage staff to contact EAP or follow-up with CISM as needed. Command wants you all to know this is not the last chapter, and we will work with our federal partners to ensure justice is served in this matter.

All staff commuting to your home units will stay in communication with their respective Team Leader. It is recommended a telephone call or text message be placed/sent every 4 hours to your Team Leader, until you reach your respective residence. Team Leaders will compose an email to Kelly Cole; kccole@blm.gov listing their respective team members and confirming all have made it to their home units without incident. If any person has any issue while in travel status they are to contact Eric Boik directly at eboik@blm.gov or (385)226-1581. Team Leaders — it's imperative you track all of your staff and keep command informed. It's equally important you provide notification once your entire team has reached their home units.

FINANCE:

BLM/USFS: Cassie Sandberg will send a separate email to each of you with your OF288 (Summarized time from CTRs) and other finance instructions to follow when you arrive at your designated time for demobilization. NPS/SETT: Cassie Sandberg will send you finance demobilization instructions from the NPS finance lead. You will not need to report to the Renaissance. You will receive additional direction from Sgt. Huther. Before demobilization all staff (except for NPS SETT) will report to the Renaissance Hotel, 3400 Paradise Road, Las Vegas, second floor, Copa B Conference Room. The Renaissance is just 1.5 blocks south of the Marriott on Paradise Road. You will need to Park in the Las Vegas Convention Center parking lot just north of the Renaissance, which is the south side of the convention center. The following is the demobilization schedule times:

*Those of you on Night shift please check out of your hotel prior to coming to your scheduled demobilization time. In addition, you will need to book a reservation tomorrow in Las Vegas at a different hotel to obtain your 8 hour rest cycle. The decision for you to change hotels is due to the inability to provide security while you rest because of the demobilization schedule.

All other staff needs to checkout prior to arrival for demobilization, make late checkout times or plan accordingly.
